### Minutes

For the **Annual District Meeting** held on **Saturday 8<sup>th</sup> October 2016 at Staplehurst.**

29 members signed the attendance book.

**2016/ADM01 Minutes and any matters arising from previous meeting: -**

- a) 2016/QMC 9<sup>th</sup> July 2016 Nettlestead

With a slight amendment the minutes were signed by the Chairman as a true record with no matters arising.

**2016/ADM02 Election of new members: -**

Sarah King of Mereworth was proposed by Douglas Bratt and seconded by Barry Evans, and Denise Edwards and Linda Hemsley, both from Barming, were proposed by David Earl and seconded by Terry Barnard. All three were duly elected.

**2016/ADM03 Forthcoming Events in the next Quarter: -**

- 1.) **District Practice – 12<sup>th</sup> November 2016.**  
This was being held at Hollingbourne with ringing from 10.00 till 12.30.
- 2.) **District Carol Service – 10<sup>th</sup> December 2016.**  
This was being held at West Peckham. Ringing from 3.30-4.30pm with mulled wine and mince pies after the service.
- 3.) **District Quarterly meeting – 14<sup>th</sup> January 2017.**  
This was to be held at Yalding. This will be one of the few afternoon meetings with ringing from 15.00 till 17.30 with a break at about 16.00 for a short business meeting and refreshments.

**2016/ADM04 Proposed Calendar for 2017/18**

The Secretary circulated copies of the proposed calendar and said that, so far, 4 towers had confirmed their venues. These were Aylesford for the QDM in April 2017; Barming for the QDM in July; St Michael's Maidstone for the practice in September; and Ightham for the ringing competitions in March 2018.

Chris Saunders confirmed that Leeds would be able to host next year's ADM in October 2017.

The Chairman said that the date in August 2017 was traditionally used for a social event and she asked the membership for their views on what type of event they wanted. The

District had run a BBQ for the last 4 years but perhaps a change was needed eg an outing, quiz night, dinner? She asked members to let the new Committee know what they wanted them to organise.

Daniel Brady said the County Youth Competition was on 22 October at Otford. It was open to those under 25 years old. If any towers had young ringers who would like to take part in the competition they should get in touch directly with Daniel.

**3.) Treasurer's report.**

The Treasurer presented the interim statement for 2016 to the meeting and explained that the final accounts were not due until the end of the year. It was worth noting that the membership had declined in the last year and monies from subscriptions had also reduced. This was not only because of declining membership but also the increasing age of the membership and increased number of members paying the over 65 rate of subscription.

**4.) District Representatives' report.**

**5.) Ringing Masters' report.**

Jack Velvick summarised the Ringing Masters' report by saying that attendances at meetings continued to be very encouraging with lots of our less experienced ringers attending. As a result the decision was taken to stop specifying special methods at meetings and instead to tailor the ringing to suit those attending. Nevertheless the standard remained good and there was still a variety of ringing with rounds and call changes as well as plain and surprise methods.

**6.) Publicity Officer's report**

All three nominees were all duly elected.

The Chairman thanked the outgoing committee for all their hard work over the last year.

**2016/ADM07 Proposed Rule Change**

Daniel Brady said that the County Committee were proposing a rule change on the aims of the KCACR which will be voted on at the County AGM on Easter Monday.

He explained that at present the Association have 5 aims and it is proposed these be reduced to a single overarching aim which will state that:

*'The aim of the Association is to foster ringing in the historic county of Kent by promoting and protecting the interests of ringing and ringers'.*

**2016/ADM 08 Any other business.**

1. The Chairman said that members may have seen an item on the County website that the Association has been generously donated a light ring of 6 bells (tenor 0.75cwt) and is considering the creation of a mobile ring for the County, at a cost of approximately £7,000. The County Committee would welcome views from the membership on this proposal and had created a survey form which is on the

website for views to be given. Further details and the Survey Form can be found at: <http://kcacr.org.uk/a-mobile-ring-for-the-kcacr/>.

2. Also on the County website is an item on the Council Review Action Group (CRAG). The Council in question is the Central Council of Church Bell Ringers. The Central Council (CC) is the representative body of all who ring bells in the English tradition. Founded in 1891 the Council is made up of over 200 members representing 65 societies and associations (like KCA) from all over the world. KCA elects 5 members to the CC on a 3-year term.

The CC has 15 permanent committees which cover a range of different specialties including Education; Public Relations; Publications; Bell Restorations; Redundant Bells; Peal Records, Methods & Compositions which aim to provide expert knowledge on their speciality. However it is considered by some to be stuck in old fashioned ways and needs updating to be relevant to today's ringers.

At this year's meeting it was decided that an independent working group should be set up to undertake a detailed review of the Council which will report back at the next meeting in May 2017 with recommendations for change. The review group, CRAG, needs a lot of input from a whole range of ringers and details of how you can have your say are also on the County website at: <http://kcacr.org.uk/review-of-the-central-council-part-2/>. The next deadline for feedback is 31 October.

3. Chris Saunders said that the current 5 at Broomfield would soon be augmented to 6, as the bell arrived today. Brian Butcher will be in charge of the work.
4. Debbie Brady asked whether the facility on the District website to upload District events direct to smartphones could be reactivated. Not all those who wished to take advantage of the facility were able to utilise it. Daniel Brady said there were some issues with it and he would speak about this outside the meeting.

## District Secretary's report for 2016 District ADM.

It is with sadness that, once again, I have to start this report with the passing of 2 ringers who were stalwarts in the District. Martin Pring passed away on 26 March 2016. He was a member of KCACR for 50 years having been a member of the band at Aylesford for many years before moving to Maidstone and joining All Saints 26 years ago. Alan Phipps, from West Malling, passed away suddenly on 14 May 2016 whilst on a tennis holiday in Corfu. He was 67 years old. As well as ringing and tennis, he was also a keen cyclist and a Magistrate and rang peals for both the KCACR and the Magistrates Association. They will both be sorely missed and we all mourn their passing.

The District 6 bell competition for 2015 held at East Sutton in March was a success with 6 teams entering the call change competition and 3 teams for the striking competition. There was a new name on the shield for the call change competition with a combined Suttons team (East Sutton/Chart Sutton) winning for the first time and Staplehurst triumphed in the method competition and represented the District at the County 6-bell competition. Well done to both teams.

District events throughout the year have been well received and very well attended. The QDM at Stansted in April was the best attended with 50 ringers present. The average attendance for the year was 31, yet again an increase on previous years.

The district barbecue this year held at Ulcombe and hosted by James Davis. We had the Dewby's Bells mini-ring, two polypins of ale and plentiful food and it was a good fun evening. The District Carol Service was held at the augmented 5 bell tower at Broomfield, with ringing before a very enjoyable service. Daniel Brady again put together a small but very effective choir from District Ringers who performed at the service.

During the year we have elected 17 new members, including two associate members at Broomfield who had donated the two bells to augment the ring from 3 to 5.

For 2017/18 once again we have a full programme of events planned.

## **DISTRICT REP'S REPORT**

### **AGM STAPLEHURST 9<sup>TH</sup> October 2016**

Although limited to the number of towers I had a chance to visit over the last year, the overall impression is that most towers seem to have a weekly practice, and those that don't, it seems, happen on a fortnightly basis. Those visitors who are able to travel can make all the difference to a tower's ringing evening or whether it takes place at all.

The biggest problem, as we all know, is finding new recruits, not only to replace those we have lost, but to be our future if we are to progress in the 21<sup>st</sup> century and beyond!

The K.C.A.C.R. general committee (at last) is undertaking and looking at ways of appealing to a wider audience, in the hope of bringing new people in, while there are still experienced ringers in our midst who can teach and train them.

With the aging ringing population, and finding quite often we have an aging congregation in our home churches, which has been our traditional procurement ground in finding new members, this has now fallen on stony ground. We can only hope these new initiatives help and overcome the situation we find ourselves in to make things happen.

Not only recruitment, but training/teaching/instilling rope skill, is also a key area, and those who teach, or who feel they could with help and a refresh in guiding a new member through initial training and rope handling, so they are able to be fairly quickly giving them enough competence to be part of a practice night, should look out for courses now available especially designed for 'teachers' and how to teach and instil good ringing habits from the start. Otherwise contact the County Training Officer (see Handbook) for more information.

## **Ringling Masters' Report for 2016 ADM**

Over the last 12 months we've seen encouraging attendance levels at many district events and some new faces. A lot of the ringing at district practices has catered to ringers at the rounds and call changes stage and those moving on to plain hunt. We haven't been following the previously established convention of setting special methods for every district practice, and we feel this has allowed each practice to cater better to those in attendance. We have had limited and balanced feedback on this. It has meant that there is more time to devote to individual requests when any are forthcoming.

It's noticeable that a number of ringers (particularly new ringers) have found district events to be useful occasions to meet other ringers in the area and build up useful connections, or the confidence to visit another tower. This is a function district events perform very well, and I hope this continues. We would always encourage any ringer, new or well-established, to visit other towers and other districts. Building up experience and connections in this way greatly helps the development of individuals and of ringing in general. We hope district practices continue to be a positive experience for everyone and would always welcome feedback on ways to improve this.
